

# Privacy Policy Speaklife68

Last updated: April 16, 2022

This Privacy Policy describes Our policies and procedures on the collection, use and disclosure of Your information when You use the Service and tells You about Your privacy rights and how the law protects You.

We use Your Personal data to provide and improve the Service. By using the Service, You agree to the collection and use of information in accordance with this Privacy Policy.

## Interpretation and Definitions

### Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

### Definitions

For the purposes of this Privacy Policy:

**Application** means the software program provided by the Company downloaded by You on any electronic device, named SpeakLife68

**Company** (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to SpeakLife68.

**Country** refers to: Netherlands

**Device** means any device that can access the Service such as a computer, a cellphone or a digital tablet.

**Personal Data** is any information that relates to an identified or identifiable individual.

**Service** refers to the Application.

**Service Provider** means any natural or legal person who processes the data on behalf of the Company. It refers to third-party companies or individuals employed by the Company to facilitate the Service, to provide the Service on behalf of the Company, to perform services related to the Service or to assist the Company in analyzing how the Service is used.

**Usage Data** refers to data collected automatically, either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

**You** means the individual accessing or using the Service, or the company, or other legal entity on behalf of which such individual is accessing or using the Service, as applicable.

## Collecting and Using Your Personal Data

### Types of Data Collected

#### Personal Data

While using Our Service, We may ask You to provide Us with certain personally identifiable information that can be used to contact or identify You. Personally identifiable information may include and is limited to:

#### Usage Data

Usage Data is collected automatically when using the Service.

Usage Data only includes the following three elements:

1. The Firebase token provided by FCM Firebase. This token is necessary to receive a notification from the SpeakLife68 app during 68 days, while the challenge endures. Extra information regarding Google Firebase Cloud Messaging:
  - Google Firebase Cloud Messaging is used to send notifications to the device of the user. This data cannot be related back to the device or the user.  
FirebaseMessaging  
Always collected
  - Collects application identifier and application version for topic subscription and unsubscription.

FirestoreAnalytics is not enabled for the SpeakLife68 app and therefore no data for FirestoreAnalytics is collected.

2. Device type: which type of device is using the application, this information is necessary for debugging faults if they occur, to examine which type of device is used. For example:
  - Android
  - Iphone
  - Ipad
3. Timezone offset, what's the difference between the UTC default timezone and You're timezone. The difference is the timezone offset which is for example 1 when living in London. This timezone offset is tracked to be able to send You the notification on the next day.
4. Register date, the date the app is installed in UTC timestamp format.

## Use of Your Personal Data

The Company does not collect any Personal Data. The Usage Data is only used to send You notifications and for debugging faults.

## Retention of Your Personal Data

Because the Company does not collect any Personal Data, retention of Your Personal Data is not relevant. The Usage Data is not related to You personal and therefore is retained once the notifications are finished and the application is removed.

## Transfer of Your Personal Data

Because the Company does not collect any Personal Data, transfer of Your Personal Data is not relevant.

## Disclosure of Your Personal Data

The Company does not collect any Personal Data, disclosure of Your Personal Data is not relevant.

## Business Transactions

The Company does not collect any Personal Data, disclosure of Your Personal Data in case of business transactions is not relevant.

## Law enforcement

The Company does not collect any Personal Data, disclosure of Your Personal Data in case of law enforcement is not relevant.

## Other legal requirements

The Company does not collect any Personal Data, disclosure of Your Personal Data in case of other law requirements is not relevant.

## Security of Your Personal Data
